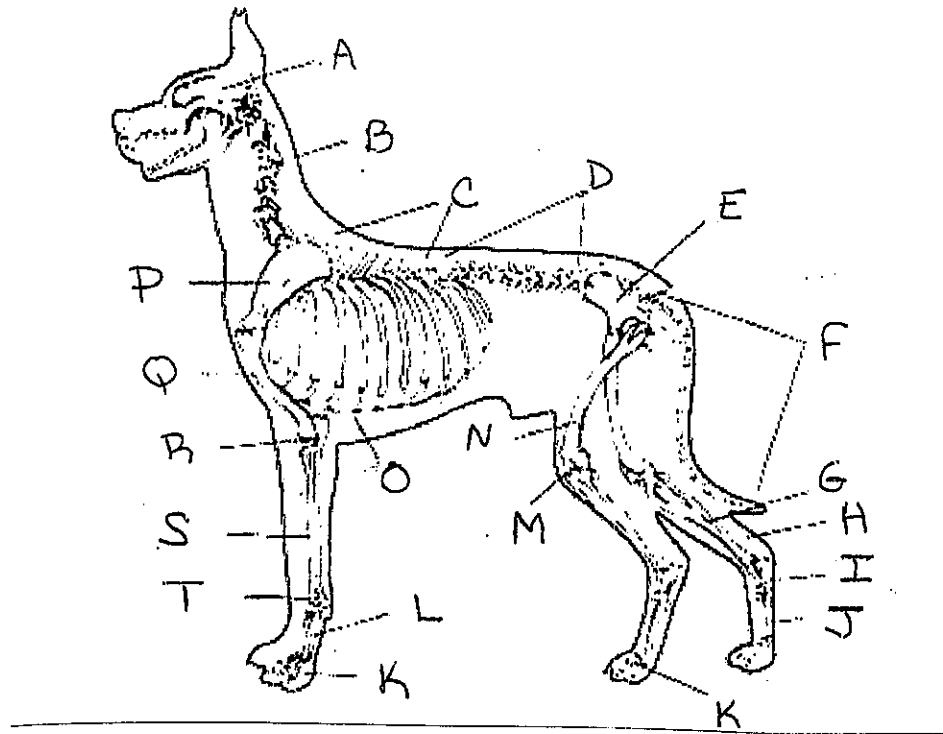

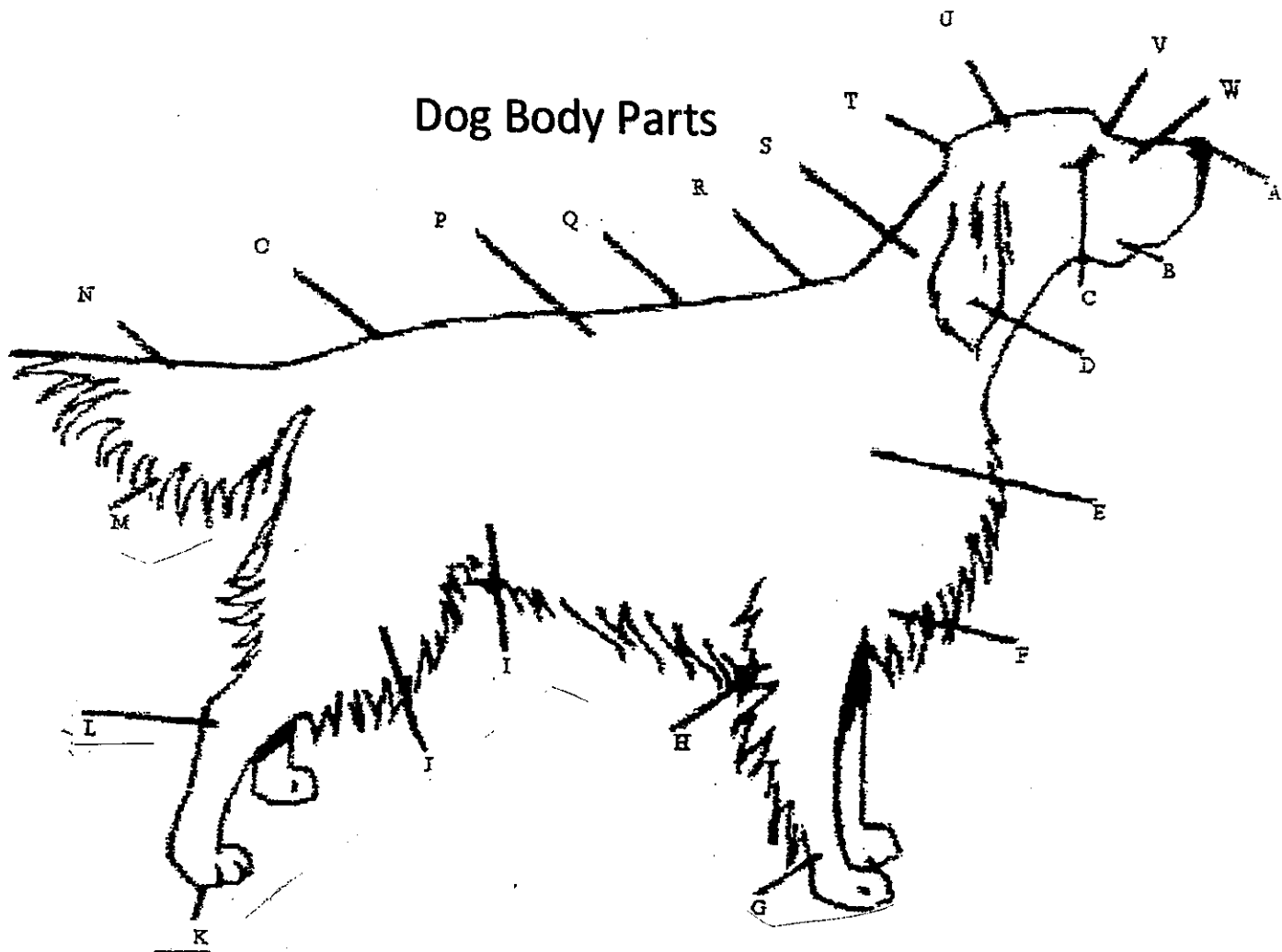
Dog Skeleton

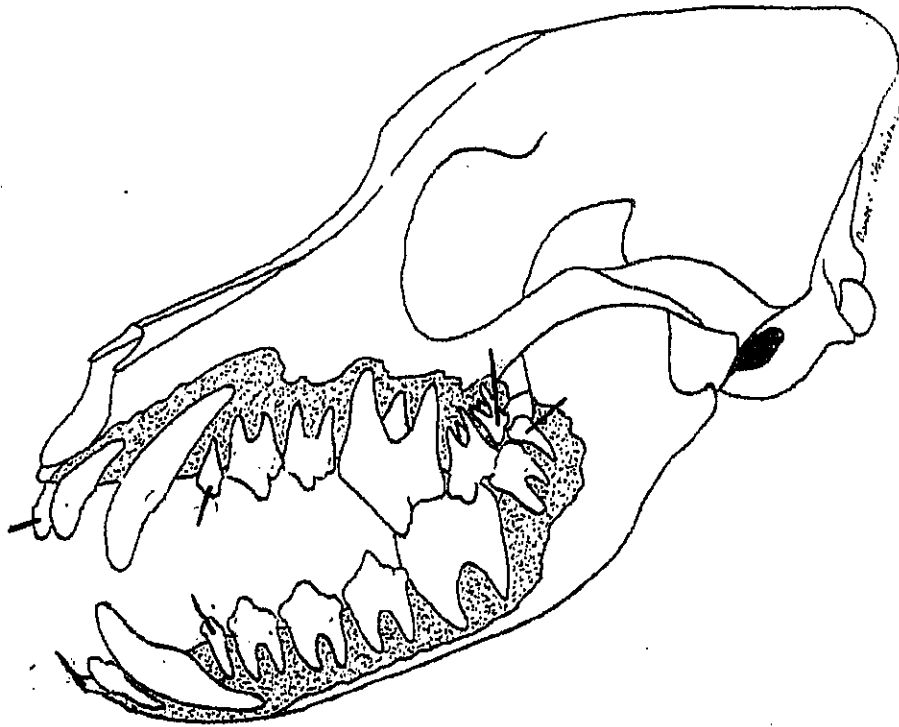
